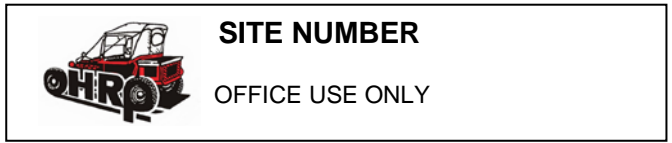

## 2019 QUEENSLAND HOT ROD SHOW

THE FOLLOWING RULES APPLY TO THE MOVE IN & MOVE OUT PERIOD

You are required to read and sign that you understand these requirements

- Every person entering the building during move in & move out periods must wear a safety vest. **NO VEST !! NO ENTRY!!** Fluro vests will be for sale at check in.
- **Covered footwear MUST be worn at all times** during move in & move out periods.
- Children under the age of 15 years are not permitted to enter high risk areas during move in and move out. Children are not permitted on loading docks at any time. A high-risk area is one where forklift operation, rigging or stand building is being undertaken.  
Children are not permitted to remain in any vehicle unattended by an adult while the vehicle is loading / unloading. Children are not to be left unattended or unsupervised in any areas within the building.
- All electrical equipment must have a current test tag.
- No alcohol is permitted in the building during move in & move out periods.
- A responsible person must walk in front of moving vehicle, clearing the way.
- All participants are liable for any damage caused to the floor, building or surroundings.
- If your vehicle is not registered you therefore have no third party insurance. It would be in your best interest to arrange cover. Without cover you will accept all responsibility for any unforeseen circumstances that may arise.
- I have read and understand the above rules and agree to abide by them and agree to follow all directions given by authorized personnel of the organizer QHRA Ltd. and enter at my own risk and release Queensland Hot Rod Association Ltd. and their agents from any liability arising from any circumstances whatsoever
